In 1997 Jane took the post of Assistant City Manager in Brooklyn Center, Minnesota, a few miles north of Minneapolis. In October, 2002 Jane returns to California as the Assistant City Manager in Daly City. In 2006 she joined the San Bruno staff as the "interim" Assistant City Manager and then served as the "Interim" Director of Public Works from May, 2006 until October, 2008 when she was appointed <u>Ukiah</u> City Manager. Picking up the Pieces: Retired Wasco City Manager Larry Pennell is the <u>Fillmore</u> "Transitional City Manager." Larry is responsible for recruiting a new Fillmore City Manager. In the meantime, Fillmore Assistant City Manager/Finance Director Barbara **Smith** is retiring on May 15 after 23-years with the City. Bell Gardens City Manager Steve Simonian is a former Chief of Investigations for Los Angeles County District Attorney Steve Cooley. Hesperia Assistant City Manager Brian D. Johnson served as Interim City Manager in Grover Beach between November, 1996 and July, 1997. He then served as the Grover Beach Administrative Services Director, and went to Hesperia in 2000 for a similar post. Berkeley Mayor Tom Bates previously served in the California Assembly from 1976 to 1996. married to Loni Hancock, a former Mayor of Berkeley who currently serves in the Assembly. Mayor Bates graduated from the University of California, Berkeley, and played on the Golden Bears 1959 Rose Bowl team. Since the introduction of term limits in 1990, State Executive and State Senate members can only hold an office for two four-year terms. For the State Assembly, the limit is three two-year terms. Before the introduction of term limits, officials were limited only by their ability to attract voters on Election Day. With his Assembly and State Senate service combined, Ralph C. Dills holds the record for longest tenure in the California State legislature. Colusa City Manager Jan Mclintock is a former Information Technical Officer in Riverside County. Placentia City Administrator **Troy Butzlaff** has a BA and MPA from the University of La Verne. He previously worked in Palm Springs, Indian Wells and Diamond Bar.
