Bob became the first Eureka City Manager in 1959, and move back to Southern California in 1962 when he was selected to be the Santa Fe Springs City Manager, a position he held for nearly 18-years when he thought he had decided to retire. He went right into an "Interim" career, first in Paramount in 1980 and then Norco in 1981. In 1982 he came out of retirement to accept the Pico Rivera City Manager post where he served for nearly 3years. 
