Santa Barbara is situated along the Pacific Ocean shoreline at the western base of the Santa Ynez Mountains. The 2010 census figures place the Santa Barbara population at 88,410. Santa Barbara is a popular West Coast tourist and resort destination. There are also five institutions of higher learning in the community including: the University of California, Santa Barbara; Santa Barbara City College; Westmont College; Antioch University; and the Brooks Institute of Photography. The city is located about 90 miles from Los Angeles. Mission Santa Barbara is one of missionary Padre Junipero Serra's California missions, built in 1782. Modern Santa Barbara is a year-around tourist destination. Tourism brings more than onebillion dollars per year to the local economy. Surfing is a big part of the Santa Barbara culture as are the Arts. Three-time Surfing World Champion Tom Curren and 10 World Champion Kelly Slater, along with surfing icon/singer-song writer Jack Johnson call Santa Barbara home.

James L. Armstrong, the current <u>Santa Barbara</u> City Administrator, began his city government career in 1977 as a Management Intern in <u>Santa Ana</u>. That same year (1977) Jim was hired as an Administrative Aide in <u>Anaheim</u>, where he was promoted to Administrative Assistant in 1978 and Assistant to the City Manager in 1979. Jim was selected to serve as City Manager of <u>Hanford</u> in 1983, and after about 7-years in that position, he returned to <u>Anaheim</u> in 1990 to be the Assistant City Manager. Jim was appointed <u>Fullerton</u> City

Manager in 1992. He served in the <u>Fullerton</u> post until 2001 when he joined the <u>Santa</u> <u>Barbara</u> staff as City Administrator. Jim has a BA from **UCLA** and an MPA from California State University, Long Beach. In 2007 he received a 30-year ICMA Service Award.



The island has been free of feral pigs since 2006.


Now more than 1,200 foxes, up from fewer than 100 in 2004, live in the wild of Santa Cruz Island.

Picking Up The Pieces: Anaheim City Manager Thomas J. Wood has resigned effective next month. Tom has served of the Anaheim city staff for some-20-years, and as City Manager for about 2 and a half-years. He served previously as Assistant City Manager, and took the top spot when former City Manager David M. Moraan retired. California Governor-philosopher Jerry Brown, known as "Governor Moonbeam" during his first stay in the Governor's office, has unveiled a pension reform plan perhaps based on his "canoe school of politics." The "canoe school of politics" notes that a little paddling to the right and then a little to the left will chart a successful course up the middle. Chula Vista City Manager Jim Sandoval has spoken out to point out the inaccuracies of a recent article that appeared in the national publication Vanity Fair. The article rudely criticizes and overlooks many of the fine people who live and work in Chula Vista. In an effort to promote efficiency and economy, Atascadero is experimenting with service delivery by closing City Hall to walk-in visitors on Fridays. The staff will continue to work and be available by telephone and email each Friday, but will be freed up to focus on city projects and special tasks. With staff reductions and continued efforts to improve cost-efficiency, this is an experiment to maintain and preserve the city's well-established customer service excellence. Atascadero's City Manager is Wade McKinney, the current CCMF President. Montebello Interim City Manager Larry Kosmont of the Kosmont Companies plans to step down from the position in December as the city seeks to appointed a permanent city manager. The city has weathered seven separate audits of the past year with Larry's professional management skills. Bellflower Assistant City Manager Lee Mingle has been serving as Interim City Manager since City Manager Mike Egan was appointed to the City Manager post in Norwalk. Lee has worked in Bellflower since 1995 when his first assignment was Public Safety Coordinator. San Mateo County Manager David Boesch, 54, has submitted his resignation, indicating that it is clear that he and the "different philosophies" board have and his resignation is in the best interest of everyone involved. David is a former City Manager in Menlo Park. Monrovia has begun a recruitment to find a replacement for City Manager Scott Ochoa, who is leaving the city in January to become the City Manager in Glendale. Scott will be filling in behind long-time veteran City Manager Jim Starbird, who is retiring after nearly 14-years with Glendale. Scott is a graduate of Claremont McKenna College and has an MPA from USC. Former San Diego City Manager Jack McGrory (1991-1997) has pledged a \$1.2 million

gift to San Diego State University, where he has taught part-time for the past 18-years. Jack is currently the CEO of La Jolla MJ Management Inc. Calistoga City Manager Richard Spitler has express confidence in his newly appointed Administrative Services Director Gloria Leon, who recently resigned from a position with the city of Hercules. Former Bell CAO Robert Rizzo has sued Bell claiming he is owed \$1.5 million in wages because he has not been convicted of a felony and has not resigned his post. He has pleaded not guilty of corruption charges: fraud and misappropriation of public funds. Kerman is recruiting a new City Manager.
