## City Managers with Oakland in Their Service History

Founded in the 19th century, Oakland grew rapidly and reached a population of 384,575 in 1950. The 2010 census puts today's Oakland population at 390,724. In the early years Oakland became a heavy industry town with some civic boosters dubbing it the "Detroit of the West." **Richard A. Walker** of the University of California, Berkeley, Geography Department, wrote an unpublished paper of interest entitled: "Oakland: Dark Star in an Expanding Universe." It provides interesting reading and can be found on-line. In 1931, **Joseph R. Knowland**, owner of the Oakland Tribune and a 6-terms Congressman, helped push through a Charter reform establishing the City Manager form of government. In 1933, **John F. Hassler**, a banker, was appointed the first City Manager, and served in that post for the next 20-some-years.

In 1943 Oakland had 44 canneries. Oakland became a center for metal-working, machinery and vehicles. Caterpillar (originally Henry Holt) tractor, Judson steel, Jacuzzi pumps, Hall-Scott motors, Jensen creamery machinery and Marchand calculator were among the "home-grown" Oakland companies. Some of the biggest names in American industry joined them by building Oakland facilities, including: Westinghouse, General Motors, Victor and others.

## City Managers with Oakland in Their Service History

Once again our primary research tool is the Who's Who Directory of ICMA. Some of the listings are meager and incomplete, and some managers are not listed at all. We do the best we can with the information at hand and our natural time constraints. We understand that we will miss some folks, and we apologize up front. We hope you enjoy this listing of California City Managers who have the City of Oakland in their work history.

**P. Lamont Ewell** has returned to Oakland as the city's Interim City Manager. The ICMA Who's Who lists his first position as Acting City Manager in Oakland in 1997. He actually had been the Oakland Fire Chief for about four-years starting in 1991 before serving as interim and Acting City Manager from 1995 to 1997. That year (1997), Lamont moved east to serve as the City Manager in Durham, North Carolina. In 2001 he returned to California to take the San Diego Assistant City Manager post, and he was elevated to City Manager in 2004. Lamont moved northerly to be Santa Monica City Manager in 2006. He left Santa Monica in 2009, served as the Interim Chief Administrative Officer in Culver City for 90-days in 2010, and was appointed to his current assignment this year. He has a BS from the University of Phoenix and an MA from the University of Maryland.

Mike worked there for about four years, and then in 1976 moved east to become a Community Service Specialist for the State of Wisconsin. Mike returned to the Pacific Coast in 1977 when he was appointed Assistant County Manager in Mendocino County. In 1983 Mike was appointed City Administrator in San Anselmo, where he worked for about four-years before he began his 18-year tenure as the San Carlos City Manager. It was 1974 when **Dr. Roger L. Kemp** began his public service career in various technical position with the City of Oakland. In 1978 he was appointed Assistant to the City Manager in Oakland. Roger left

Oakland in 1979 when he was selected to serve as the City Manager in Seaside. In 1983 Roger moved to Southern California to take the Placentia City Administrator post, and he worked there until 1987 when he moved east to become the City Manager in Clifton, New Jersey. In 1993 Roger was appointed to the City Manager position in Meriden, Connecticut. After a dozen years in Meriden, Roger returned to California in 2005 to serve briefly as the City Manager in Vallejo. He returned to Connecticut in 2006 to take the Town Manager post in Berlin, Connecticut. Roger was a Fellow at the Academy of Political Science in New York starting in 2008, and beginning in 2009 Roger has been serving as President of Kemp Consulting in Connecticut. Roger earned a BS and MPA from San Diego State University, and a PhD and an MBA from Golden Gate University. Roger participated in the ICMA Exchange Program to Australia. He was the President of the Connecticut Town and City Management Association in 2002-2003 after working his way through the Executive Board Chairs. Roger continues to serve on the ICMA Governmental Affairs & Policy Committee and he is a Legacy Leader. Roger was the recipient of a 30-year ICMA Service Award in 2004. He has taught graduate seminars in the evening during his city management career in many schools, including: California State University, Fullerton; California State University, Long Beach; Golden Gate University; and the University of California, Irvine.

Saxophonist **John Goss**, a veteran public manager, has been appointed Interim City Administrator in Carmel-by-the-Sea replacing the retiring **Richard Guillen**. John started his public service career in 1962 as an Administrative Intern in Phoenix, Arizona. In 1963 he joined the San Diego city staff as an Assistant Administrative Analyst, and in 1964 John moved north to be the Assistant to the City Manager in Fremont. John took the Assistant City Manager post in Alameda in 1967, and he was appointed Alameda City Manager in 1973. In 1980 John joined the Oakland city staff as the Director of General Services, and he served there until 1983 when he returned to Southern California to accept the appointment as Chula Vista City Manager. Detroit Public Schools Emergency Financial Manager **Robert C. Bobb** joined the Kalamazoo, Michigan city staff as the Assistant Utilities Director in 1972 following about four years in the private sector. He became the Kalamazoo Assistant City Manager in 1974 and in 1976 he was appointed City Manager. In 1984 Robert came west to California to accept appointment as Santa Ana City Manager, and two years later he move back east to serve as the Richmond, Virginia City Manager where he served for about 11-years. Robert returned to California in 1997 to be the Oakland City Manager and Executive Director of the Oakland Redevelopment Agency. In 2003 he was appointed City Administrator in the District of Columbia (Washington, D.C.), and in 2009 he started his current assignment in Detroit. Robert has a BA from Grambling State University and an MBA from Western Michigan University. He also completed the certificate program for Senior Executives in State and Local Governments from Harvard University's John F. Kennedy School of Government, where he served as a member of the Executive Alumni Council. He served as the President of the National Forum for Black Public Administrators between 2001 and 2003. In 2002 he received an ICMA 30-year Service Award. He was ICMA's 2001 recipient of the In-Service Training Award in Memory of Clarence E. Ridley. He received the ICMA L.P. Cookingham Award for Career Development in 2001, and in 1991 he was honored with the William H. Hansell, Sr. Award issued by ICMA. In June, 1950 he move to Palo Alto as City Manager and served there for nearly 16-years. In January, 1966 Jerome was appointed Oakland City Manager and he served there for a half-dozen years before moving to Southern California as the Glendale City Manager in 1972. He retired in June, 1978. He earned a BA from the University of the Pacific in Stockton. His last listed address is in Scottsdale, Arizona.

**John A. Flores** worked 30-years in municipal government before retiring at age 60 in 2006. The first job listed for John in the ICMA Who's Who Directory is Assistant to the City Manager in Oakland in September, 1976. In 1988 he was promoted to the Oakland Deputy City Manager post, but left the city that year to join the Emeryville staff as the City Manager. John served as the Emeryville City Manager until his retirement; some 18-years. He has a BA from San Jose State University and an MPA from Golden Coast University. John is currently listed as a Founding Supporter of the "Let's Go Oakland: Keep the A's." In January it was announced by Oakland officials that John has volunteered to serve as an adviser to the City Administrator's office responsible for Oakland's budget and economic Development.

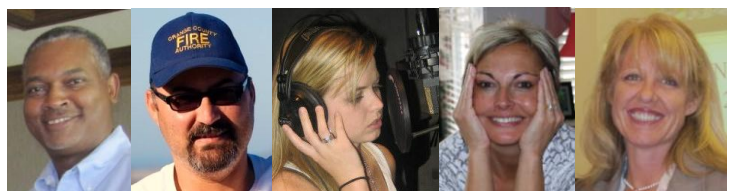
