Spotlight on Finance Directors



This is Trackdown's **Jack Simpson** and his grandson **Tyler Simpson** at the Meteor Impact Crater east of Flagstaff, Arizona; near Winslow. It was formerly known as the Canyon Diablo Crater, and fragments of the meteorite are officially known as Canyon Diablo Meteorites. Scientists refer to the crater as Barringer Crater in honor of **Daniel Barringer**, who was first to suggest that it was produced by a meteorite impact. It is about 4,000 feet in diameter. and 570 feet deep. The crater was created about 50,000 years ago.




