

In 1974 Bud was appointed Assistant City Manager in Monrovia, and in February, 1977 he was elevated to the Monrovia City Manager position. Bud left Monrovia in 1983 when he was selected to serve as the Downey City Manager, and in 1985 he moved to Burbank as that city's City Manager. Bud served as the Burbank City Manager for some 17-years. He left there in 2003 at the gae of 57-years old to the Chief Executive Officerbecome Administrator of the Los Angeles Community Redevelopment Agency. He took over from departing Administrator Jerry Scharlin. Bud ioined Mayor Antonio R. Villaraigosa's administration as Deputy Mayor for Commercial and Residential Development in July, 2005. Bud was then appointed General Manager of the City of Los Angeles Department of Building and Safety. He is currently serving as the Executive Director of the Los Angeles Convention Center. Bud earned a BA from the University of California and an MPA from the University of Southern California (USC). In 2001 he was the recipient of a 30-year ICMA Service Award. There is a park in Burbank named for Bud: Robert Ovrom Park and Community Center. Ovrom Park is the first newly active park to be developed in the City since 2002. The park was completed in the fall of 2008.






