## CITY MANAGERS WITH CHICO EXPERIENCE.

Located at the intersection of State Route 99 and State Route 32 is the largest city by population in Butte County, California; the City of <u>Chico</u>. The 2010 census puts the <u>Chico</u> population at 86,187, up from 59,954 at the time of the 2000 census.

Chico's was founded in 1860 by **John Bidwell**, a member of one of the first wagon trains to reach California in 1843. Please remember that there were no highways for the wagons to follow. It was an amazing adventure difficult to imagine in this day of solar powered electric lights, cell phones in every pocket and microwave cooking. During the Civil War, the California Militia was deployed from Camp Bidwell about a mile outside of <u>Chico</u>.

<u>Chico</u> incorporated as a municipality on January 8, 1872. It is governed by a 7-member City Council and a City Manager. <u>Chico</u> is home to California State University, Chico; Nettleton Stadium, home of the Chico State Wildcats baseball team; and Silver Dollar Speedway on the Butte County Fairgrounds, home of the Gold Cup Sprint Car Race. <u>Chico</u> is known as a "bicycle-friendly" community. In 1997 <u>Chico</u> was ranked as the number one cycling city in the Nation by Bicycle Magazine.

Almonds are the number one crop in the area, only recently edging our rice. Other area crops include: walnuts, kiwis, olives, peaches and plums.

One of the <u>Chico</u> area attractions is The Honey Run Covered Bridge. It is about half way between <u>Chico</u> and <u>Paradise</u> where it crosses Butte Creek. It was open to public traffic until an accident in 1965 damage it. It is currently part of a County Park, and listed on the National Register of Historic Places (Listed in 1988).

<u>Chico</u> has some fine public officials and has had the service of some outstanding City Managers. Though some college towns in other areas have gained reputations for public agency instability and quick management turnovers, this is not the case in <u>Chico</u>. When **Dave Burkland** was appointed City Manager in 2007, he was only the 4th Chico City Manager in the previous 53-years.

Recruited from Hemet by his former boss, City Manager Brian Nakamura, to serve as the Chico Assistant City Manager, Mark A. Orme was appointed Chico City Manager when Brian was recruited to follow the retirement of City Manager legend Ted Gaebler in Rancho Cordova. 



#### City Manager Doug Prichard in the World Body Surfing Championships.

Doug wrote us a note following his competition. We have decided to share it, as it is a good example of staying active as we age. Doug wrote:

As a fellow body surfer, I thought I would let you know how the World Body Surfing Championships went in Oceanside August 16-17. I placed fifth in the 55-64 age group, which is actually a pretty tough group because it includes Mark Cunningham, probably the most famous body surfer in the world next to body boarding (and body surfing) legend Mike Stewart. Plus, as it turns out, body surfing is an old man's sport. There were probably more entrants (about 50) in my division than any other age group. There were about 350 entrants overall. It was interesting to hear the contest organizers plead with the old guard to pass the torch, so to speak, and recruit younger talent. I always knew that body surfing was a bit of a niche sport, but to hear them tell it, you would think the sport was dying out.

As for the contest, it was held at Oceanside Pier on both the north and south sides simultaneously. Swell was 4-8 feet from the south, with decent, but not great shape, and water temp in the upper sixties. Three judges score each wave and they add up the points. The three highest scoring waves count for the heat total. If you cut someone off, you only get two scoring waves, so it's critical not to shoulder hop. Three of six contestants advance from each heat into the next round.

My son Michael competed in the 18-24 age group and was knocked out in the second round.

I placed third in my first round heat Saturday morning, which advanced me. I won my second round heat (beating the eventual age group winner in the process), which was notable for its lengthy Iull. I had doubts mid-way through the heat that I would even catch the three scoring waves I needed. Sunday morning I had a semi-final heat which included the aforementioned Mark Cunningham. The semis were by far my best heat, even though I still only placed third, which advanced me to the finals. The cool thing about that heat was the chance to call off Cunningham because I had position on a great wave and he had to back off or risk a severe penalty. The finals were not my best heat, but I had fun nonetheless. It was really cool to be in the water with some really good body surfers.

When they announced my fifth place finish I was a little disappointed, as I thought I had a shot at finishing as high as third, but in hindsight, for the heat I had, fifth was probably about right.

The thing I really came away with is the feeling that it is practically impossible to judge body surfing as the rides are short and there are limited maneuvers you can do to impress the judges; it's hard to keep track of all the contestants in the water, especially if several riders are on waves at the same time; and there is a lot of luck involved when it comes to wave availability.

As the Beach Boys once sang, "Catch a wave and you're sittin' on top of the world!"

By the way, I took my 91-year old father down to T-Street in San Clemente this past weekend to look at the surf he used to ride. It was about 6 feet and great shape. He said, "Man, I wish I could still do that!" Hope all is well with you.
