## Women Serving in Cities from Vallejo to Villa Park

Vallejo is a waterfront community in the County of Solano in the north bay area of San Francisco Bay. The city is named for General Mariano Guadalupe Valley. He was a strong supporter of California's statehood and one of the first members of the California State Senate. The city twice served as the capital of the state of California; once in 1852 and again in 1853. Vallejo incorporated in March, 1868. The current City Manager is **Greg Nyhoff**, and **Anne Cardwell** is the Assistant City Manager. **Dawn Abrahamson** is the City Clerk.



**Anne Cardwell** began her public service career as an Executive Secretary in the City of Benicia in 2003. She was promoted to Assistant to the City Manager in 2006, and served as the Benicia Assistant City Manager from January, 2014 to July, 2016. Anne was

appointed Assistant City Manager in the City of Martinez in 2016. She joined the Vallejo city staff in December, 2018 as the Assistant City Manager. Anne earned a BA in psychology from the University of California, Berkeley, and a Master's degree in educational psychology from the University of California, Los Angeles (**UCLA**).

## John Russo Receives League of California Cities Lifetime Achievement Award

Members of the League of California Cities Past Presidents Council selected former city manager, city attorney, city council member, and League Board of Directors member **John Russo** as the recipient of the 2020 Past Presidents' Lifetime Achievement Award. He received the honor during the opening General Session of the League's 2020 Annual Conference & Expo.

After graduating from Yale with honors and finishing law school at New York University, John became a legal aid lawyer in St. Louis, Missouri. In 1987, at 28-years old, John moved to Oakland where he knew no one. Seven years later, he was elected to the Oakland City Council in a landslide.

John is the only person in California who has worked as a City Council member, a full-time City Attorney, and a City Manager. His municipal roles have been varied, and so have the cities in which he has served: Oakland, Alameda, Riverside, and Irvine.

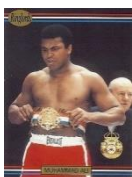

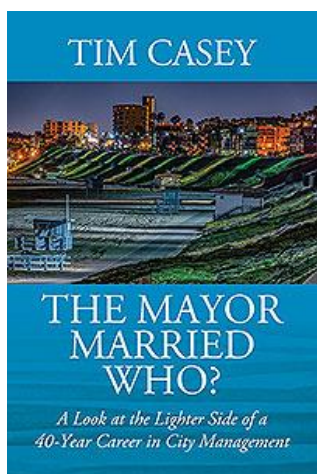

## Women Serving in Cities from Vallejo to Villa Park

Victorville is found in San Bernardino County's Victor Valley. In 1858, **Aaron G. Lane** founded a way station called "Lane's Crossing" in what is now known as Victorville. It served travelers. The area's history is filled with pioneers and prospectors coming to California. The city did not incorporate until September, 1962. The 2019 estimated population is 122,385. **Keith C. Metzler** is the Victorville City Manager, and **Charlene Robinson** is the City Clerk.



**Sophie (Escobar) Smith** is one of two Victorville Deputy City Manager. The other is **Jenele Davidson**. Sophie joined the Victorville city staff in August, 2000 as an Assistant Director of Economic Development, a position she held for more than a dozen years. ## Women Serving in Cities from Vallejo to Villa Park



Villa Park is a city in Orange County. The city was known as "Mountain View" in the 1860s. The U.S. Post Office refused to allow the name because there was already a "Mountain View" Post Office, and the area became known as Villa Park. At the time, it was an agricultural area. The Serrano Water District was established to serve the area, and still provides the city water. Villa Park was incorporated in January, 1962. The City's 2019 estimated population is 5,790. **Steve Franks** is the City Manager and City Clerk.

**Kim Chaudhry** works as a Senior Management Analyst at Villa Park City Hall.

**Alyssa Manassero** is a Management Analyst for the City of Villa Park.

**Carolyn Veregge** became the City Manager of Villa Park in 1985. She worked as the City Clerk with **Arthur Simonian**, when he worked as a part-time consultant City Manager for the City. Tennessee-reared, Carolyn began working for Villa Park as a part-time secretary and moved up to Deputy City Clerk, and then City Clerk in 1978. She credited Yorba Linda City Manager **Art Simonian** for her understanding of the City Manager position.

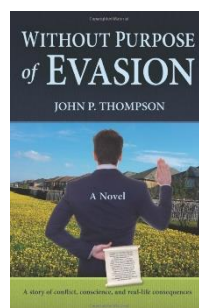

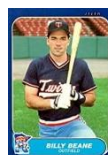
