Atwater is a city on State Route 99 in Merced County. The railroad reached Atwater in the 1870s and a town grew up because of the railroads

impact. The first post off in <u>Atwater</u> opened in 1880, and the city incorporated in August 1922. The city is named for **Marshall D. Atwater**, a wheat farmer whose land was used by the railroad for its local station. The Castle Air Force Base, the former World War Merced Army Airfield, was developed north of Atwater. The 2019 estimated population is 29,559. **Lori Waterman** is the <u>Atwater</u> City Manager, and **Lucy Armstrong** is the City Clerk. **Mark Borba** is the elected <u>Atwater</u> City Treasurer.

Lori Waterman was appointed Atwater City Manager in August 2018 after serving as Interim City Manager. She originally joined the city in 2006 and worked as the city's Grants Manager. She was working as the Interim Director of Development Services before being elevated to Deputy City Manager in March 2018 and then Interim City Manager in April. The Atwater City Manager recruitment had been ongoing since the last City Manager, Frank Pietro, retired in December 2016. A number of Interim City Managers have served since, including former Merced City Manager John Bramble, who was the Atwater Interim City Manager for about 6months in 2017. Lori became the sixth City Manager in Atwater in two-years period.

**Kellie Jacobs-Hunter** is the Finance Director for the City of <u>Atwater</u>. Kellie served as the Administrative Services Director in the City of <u>Turlock</u> prior to joining the <u>Atwater</u> city staff. She worked in <u>Turlock</u> from March 2015 to September 2019.

Human Resources Director **Jeanna Del Real** has worked for the City of <u>Atwater</u> for more than 33-years. She joined the city in May 1988.

Vernice Haddix served as the Atwater Public Works Director from June 2019 until October 2020. Prior to that he was a Maintenance Manager in the City of Yreka (2010-2011), and he worked for the County of Calaveras before that as Deputy Director in Public Works (2007-2009). #### **Howard Lee Chambers**

(December 1944 - June 2021)



Howard died peacefully in his sleep on the morning of Wednesday, June 9 2021, having fought cancer like a warrior for over 6 years. Howard was 76. He was surrounded by family at his Brea home. He kept his sharp wit, hearty appetite and keen sense of diplomacy until the very end. Condolences to Mary and his family and friends.

**Howard Chambers**: After working as a Recreation Leader in the City of Lakewood, Howard L. Chambers, was selected to serve as a Lakewood Administrative Aide in 1968. In 1969, the year American Astronaut Neil Armstrong became the first person to set foot on the Moon and proclaim, "That's one small step for man, one giant leap for mankind," Howard took an Administrative Assistant position in Rosemead. He was appointed to the Rosemead Assistant City Manager post in 1972. Howard rejoined the staff in the City of Lakewood in 1973 as an Executive Assistant to the City Administrator. He was appointed City Administrator in 1976; the year Russian gymnast Nadia Comaneci scored the first ever perfect score while she won 3 gold medals at the Montreal Olympics with 7-perfect "10" scores. The Lakewood chief executive position was changed in 1980 and Howard became the Lakewood City Manager. In 2011 Howard tried to retire, but was urged to re-think that decision, so after serving in an "interim" capacity for a few months he was reappointed Lakewood City Manager in 2012. Howard earned a BS from Long Beach State University (California State University, Long Beach); and an MA from Pepperdine University. He also earned an MPA from the University of Southern California (USC). Howard completed a Program for Senior Executives in Public Administration at the Kennedy School of Government at Harvard University in 1988. In 2001 Howard was the recipient of an ICMA Management Innovation Award in Arts/Cultural. He served on the ICMA Committee on International Activities from 1994 to 1997, and he is a former participant in the ICMA Japan Fellowship Exchange and the Exchange Program to New Zealand. Howard and his wife Mary, married in 1976, reside in Brea. Howard, 68, is known as a friendly and tenacious competitor in golf and tennis and many other games and sporting activities. Ask him about shuffleboard! Howard is the recipient of a very rare 45-year ICMA Service Award. In 2013 Howard received a very rare 45year ICMA Service Award. He was awarded an ICMA Management Innovation Award-Arts/Cultural in 2001. He participated in ICMA Exchange Programs to Japan and New Zealand.

Livingston is uphill from where the Southern Pacific Railroad tracks cross the Merced River. Highway 99 follows the tracks through the town. The first Livingston post office opened in 1873,

closed in 1882, and re-opened in 1883. The town was named for **Dr. David Livingstone**, an international celebrity as a British explorer of Africa in the late 1800s. An error on the postal application resulted in the difference in his name's spelling and the town's. Livingston incorporated in September 1922. Its 2019 estimated population is 14,896. **Jose Antonio Ramirez** is the City Manager and **Monica Cisneros** is the Deputy City Clerk.

City Manager Jose Antonio Ramirez is working his second stint with the City of <u>Livingston</u> starting in November 2017. He worked in the private sector from 1997 and 2003 before he was appointed City Administrator in <u>Orange Cove</u> (2000-2003). Jose then became the City Manager in the City of <u>Firebaugh</u> (2003-2011), and then moved to the City Manager position in <u>Livingston</u> in 2011. Jose left the post in 2015, and then was re-hired as City Manager. In 2020 Jose received a 20-year ICMA Service Award.
