City Executives in Cities in Kings County

An 1805 expedition to the area discovered the river they named El Rio de las Santos Reyes...River of the Holy Kings. In 1848 with the conquest of California, the new government changed the name of the river to the Kings River, after which the county was named.



<u>Hanford</u> is in the south-central San Joaquin Valley and serves as the county

seat for Kings County. In the mid-to-late 1870s the Southern Pacific Railroad spurred growth in labor and population. <u>Hanford</u> was named for **James Madison Hanford**, an executive of the railroad. The earliest known document labeling the settlement as "Hanford" is on a 1876 map of <u>Tulare County</u> which once included the territory of present-day <u>Kings County</u>. <u>Tulare</u> incorporated in 1891, as the need for fire protection was recognize following several major fires that destroyed much of the business district. When Kings County was created in 1893 from the western part of Tulare County, <u>Hanford</u> became the county seat in 1901 and the Star



Restaurant opened on Sixth Street in <u>Hanford</u> across from the Southern Pacific tracks. The Star Restaurant is still doing business at the same

location today. The 2019 estimated population of <u>Hanford</u> is 57,703. **Mario Cifuentez** is the City Manager and **Natalie Corral** is the City Clerk. **Bob Dowd**, a Hanford High School graduate and former Student Body President (1963-1964) and former U.S. Marine, is the <u>Hanford</u> City Attorney.



Waist high wild oats covered the Kettleman Plains area that Spanish soldiers and explorers call <u>Avenal</u>, which mean "oat field." Native Americans in the area knew that there was oil in

the hills, as there was natural seepage around Coalinga. On March 27, 1927, the Milham Exploration Company drilled a more than 7,000foot well that produced oil so fine that it had a white color and, according to some, could be used unrefined to fuel automobile engines. The oil discovery made Avenal a boomtown. In 1929, Standard Oil Company surveyed the town site to build a town. The collapse of the once "Oil Fields Capital" came with the intrusion of salt water. In the 1960s there was an influx of agricultural workers into the town, and in the 1970s the California Aqueduct and the opening of Interstate Highway 5 brought a new prosperity. Avenal incorporated in September 1979. The Avenal State Prison opened in 1987, bringing many new families to the city. The 2019 estimated population is 13,496. Antony V. Lopez is the Avenal City Manager and Maria "Angie" Ortiz is the City Clerk. The Avenal Chief of Police is **Russell Stivers**.

Corcoran: <u>Corcoran</u> was founded by **Hobart Johnstone Whitley**, who was a prominent land developer in Southern California. The City's main street is named for the founder. He visited the area in

1905. He wanted to name the town "Otis," after Harrison Gray Otis of the Los Angeles Times, The City incorporated in August 1914. The local economy then and now is agriculture-based. Corcoran is most famous as the location of a California State Prison. It was home to famous inmates Charles Manson and Juan Corona. Corcoran is also the site of the California Substance Abuse Treatment Facility. The two facilities housed a combined total of 9,592 inmates on January 1, 2015. Inmates are counted in the US Census and by the California Department of Finance. Incarcerated people in the two facilities comprise more than 43% of Corcoran's 2019 estimated population of 21,960. Greg Gatzka is the City Manager and Marlene Spain is the City Clerk and Assistant to the City Manager.

In April 1871, **Dr. Lovern Lee Moore** of <u>France</u> made his home in what was western Tulare County, now the City of <u>Lemoore</u>. It was on the northern shoreline above the high-water

mark of Tulare Lake, then potentially the largest freshwater body of water in the United States, outside of the Great Lakes. By the time Dr. Moore arrived, scores of individual farms dotted the landscape, but as Tulare Lake retreated, more land became available. Wells were easy to dia, as the water table was unusually high. Water was plentiful for irrigation from shallow wells farm families installed. Raising sheep and farming grains were principal concerns in the area. Lemoore was not founded until later in 1877. The city was incorporated in July 1900. The 2019 estimated population of Lemoore is 26,725. Nathan Olson is the City Manager and Michelle Speer is the Assistant City Manager. Marisa Avalos is the City Clerk.


