There are 14 cities in Alameda County, California. The first six (6) of those cities listed alphabetic Alameda, Albany, Berkeley, Dublin, Emeryville and Fremont. Alameda County is part of the San Francisco-Oakland-Berkeley, CA Metropolitan Statistical Area, and the San Jose-San Francisco-Oakland, CA Combined Statistical Area.

Current city managers in this Alameda County "Six" include **Eric Levitt**, who is leaving to be the <u>Fullerton</u> City Manager, **Nicole Almaguer**, **Dee Williams-Ridley**, **Linda Smith**, **Christine Daniel**, and **Karena Shackelford**.

We will also attempt to address "Servant Leadership" as a management concept that we had not heard of until recently through **Roy Pederson**.





Alameda is a city that is primarily on Alameda Island in Alameda County. The name "Alameda" is Spanish for "grove of poplar trees," or "tree-lined avenue." It was designated as the city's

name when the city was founded in June 1853 not long after California joined the United States following the Mexican-American War of 1848. The first post office was opened in 1854. The first train on the First Transcontinental Railroad to reach the shores of the San Francisco Bay arrived on September 6, 1869 at, the Alameda Terminal. This was the first completed trip of the first coast-to-coast transcontinental railroad trip North America. The 2020 estimated population of the City of Alameda is 78,280. Eric Levitt served as City Manager starting in April 2019 but recently took the City Manager position in the City of Fullerton. Gerry Beaudin is the Assistant City Manager and Sarah Henry is the Communications & Legislative Affairs Officer.

In 1908, some local women in the Albany area protested the dumping of Berkeley garbage in their community. Armed with two shotguns and a twenty-two-caliber rifle, they confronted the waste wagon drivers near what is now the corner of San Pablo Avenue and Buchanan Street. The women easily turned the drivers of the horse-drawn garbage wagons around heading for home. Shortly after the incident, the residents of the town voted to incorporate as the City of Ocean View. In 1909, voters seeking to distinguish the city from the adjacent section of Berkeley which was named Ocean View. The city was renamed in honor of Albany, New York, the birthplace of the city's first mayor, Frank **Roberts**. The 2020 estimated population is 20,271. Nicole Almaguer is the City Manager and Anne **Hsu** is the City Clerk.



Nicole Almaguer began her tenure as the City of Albany in November 2018. Took the position when City Manager Penelope Leach Crumpley retired in 2017. Nicole was the Assistant City Manager and

took the position first as "Interim." Nicole previously served as the <u>Albany</u> City Clerk. Penelope had worked for the city for 10-years, four as City Manager. She took the post when City Manager **Beth Pollard** retired. Beth served as City Manager from 2001 to 2013. She earned a BA in environmental studies from the University of California, Santa Barbara and an MS in environmental science from the University of San Francisco.

In 2020 he received a very rare 45year ICMA Service Award.



Berkeley is home to the oldest campus in the University of California System, the University of California, Berkeley. Politically, the area that has become

Berkeley was initially part of a vast Contra Costa County. A division of the county created Alameda County in 1853. During this period Berkeley was the northern part of the "Oakland Township" in Alameda County. During this time, Berkeley was mostly a mix of open land, farms and ranches with a wharf on the bay. 1872 saw the opening of the first Berkeley post office. The city incorporated in April 1878 and a Chartered was approved in March 1895. The 2020 population estimate is 124,321. Dee Williams-Ridley is the City Manager and Mark Numainville is the City Clerk.

Dee Williams-Ridley became the Berkeley City Manager in February 2020. She served as the Deputy City Manager from 2015 until her appointment to City Manager. Dee served as the Sacramento County Personnel Services Manager from December 2000 until September 2006 when she went to the County of San Mateo as Assistant Director of Human Resources. In January 2010 Dee became the Deputy City Manager in the City of Modesto where she worked until going to Berkeley. Dee earned a BA from California State University, Sacramento. She also took political science and government courses at Oklahoma City University.

Tasha Tervalon is the <u>Berkeley</u> Assistant to the City Manager starting in January 2016. She was previously a Health Services Supervisor. She earned a BA from the University of Michigan and an MA from the University of Pennsylvania.



<u>Dublin</u> was previously known as Amador and Dougherty's Station. The large number of Irish who lived there are responsible for the area's "Dublin" label. The post

office formally adopted the name in the 1890s. The city incorporated in February 1982. The 2020 estimated populations is 72,589. Veteran <u>Dublin</u> City Manager **Richard C. Ambrose** served the city from 1982 until 2008. **Linda Smith** is the currently City Manager and **Marsha Moore**, MMC, is the City Clerk.



<u>Dublin</u> City Manager **Linda Smith** began her working career in the private sector starting with a public relations firm in 1994. In March 2002 Linda joined the staff in the City of <u>Tracy</u> as an Economic Development

Analyst. In June 2005 she took an Economic Development Manager position with the City of Brentwood. Linda left Brentwood to join the City of Dublin staff in February 2009 as the Economic Development Director and Public Information Officer. Linda was appointed to the Dublin Assistant City Manager position in December 2013 and became the City Manager in Dublin in January 2020 following the retirement of City Manager Christopher Foss.
