Colusa County has two incorporated cities: <u>Colusa</u> and <u>Williams</u>. Del Norte has only <u>Crescent</u> <u>City</u>, and El Dorado County has <u>Placerville</u> and <u>South Lake Tahoe</u>. The cities of <u>Orland</u> and <u>Willows</u> are in Glenn County.

The <u>Colusa</u> Finance Director is **Ishrat Aziz-Khan**, who also serves as the Gridley Director.

<u>Williams</u>, California was originally named Central by the postal service in 1874. The town was renamed in 1876 in honor of **W. H. Williams**, who platted the townsite. The City of <u>Williams</u> was incorporated in May 1920. Granzella's Restaurant & Delicatessen in <u>Williams</u> is an established Interstate 5 travelers' respite for food and relaxation. The 2019 estimated population is 5,408. **Frank Kennedy** is the <u>Williams</u> City Administrator, and **Mariana Pineda** is the City Clerk.

## Cities in Four Counties: Colusa, Del Norte, El Dorado and Glenn Counties

Placerville was previously known as Old Dry Diggins, Dry Diggings and Hangtown. It is the county seat in El Dorado County. Following the discovery of gold in 1848 at Sutter's Mill in nearby Coloma the California Gold Rush was off and running. Several law breakers were hanged since there was no formal law enforcement, hence the name Hangtown. The named Placerville came in 1854 and the city was incorporated that May. Placerville became the central hub for the Mother Lode region's mining operations. At one time it was the third largest California city. The estimated 2019 population is 11,175. Cleve Morris is the City Manager and Regina O'Connell is the City Clerk and Human Resources Officer. The Director of Community Services is Terry Zeller.

# Cities in Four Counties: Colusa, Del Norte, El Dorado and Glenn Counties

<u>Placerville</u> City Manager **Cleve Morris** began his public service career in 1989 with Sandy City, Utah. In 1990 he joined the city staff in <u>Lathrop</u> as Administrative Services Manager, and he became Assistant to the City Manager in 1994. Cleve was hired to be the <u>Newman</u> City Manager in 1998 and in 2003 he took the <u>Patterson</u> City Manager position, where he served for the next seven years before moving to <u>Placerville</u>. Cleve earned a BA and MPA from Brigham Young University. In 2009 he received a 20-year ICMA Service Award.

<u>South Lake Tahoe</u> is located along the southern edge of Lake Tahoe. The city incorporated in November 1965 and combined the unincorporated communities of Al Tahoe, Bijou, Bijou Park, Stateline, Tahoe Valley and Tallac Village. A South Lake Tahoe post office was established in 1967. Gambling came to the Lake in 1944 across the State line from South Lake Tahoe in Stateline, Nevada. The 2020 population is 21,330. Joe Irvin is the City Manager and Lindsey Baker is the Assistant to the City Manager and Public Information Officer. Susan Blankenship is the South Lake Tahoe City Clerk and Joanne **McDonough** is the Assistant City Clerk. The Director of Finance is Olga Tikhomirova and Lauren Thomaselli is the Parks and Recreation Director. Doesn't seem right to talk about South Lake Tahoe without mentioning former City Manager David Jinkens; a veteran public service manager.





City of <u>South Lake Tahoe</u> City Manager **Joe Irvin** is an ICMA credentialed manager. Joe served as an Assistant City Planner for the City of Sequim, Washington starting in May 2005. Joe was elevated to Associate City Planner and Interim Planning

Director in January 2008. He moved from that job in October 2011 to take the position of Zoning Administrator and Interim Community Affairs Director for the City of Marco Island, Florida. Orland was incorporated in 1909 and the first post office opened in 1916. Orland is named for one of the first irrigation projects of the U.S. Bureau of Reclamation, the Orland Project which still provides agricultural irrigation water. During WW II a United State Army airfield was established in Orland and used for training pilots. The Boeing B-17 Flying Fortress was one of the planes used there. The airfield is now a civil airport operated by Glenn County. In 2017 Orland declared itself the "Queen Bee Capital of North America" since it is unmatched for the production of queen bees used by local commercial apiaries. Car dealer mogul Cal Worthington owned a 24,000-acre ranch in Orland and died there at the age of 92. Peter Carr is the Orland City Manager.

**Peter Carr** left the private sector in May 2007 when he became the City Administrator in the City of <u>Biggs</u> in Butte County. Pete had positions with the International Paper Company and also with TFI Benchmark, LLC. After working for <u>Biggs</u>, Pete joined the city staff in <u>Orland</u> as City Manager in May 2012. He earned a BA from California State University, Sacramento. In his spare time, Pete is a coach and co-founder of Chico Challenger Baseball, a youth league that is much like the Little League format.

<u>Willows</u> is the county seat of Glenn County. A post office opened in "Willow" in 1862 and the name was changed to <u>Willows</u> in 1916. The Willows Auxiliary Field (1942-1945) was used for training World War II pilots. The 2019 estimated population is 6,072. **Marti Brown** is the <u>Willows</u> City Manager. A recruitment for a new <u>Willows</u> City Clerk closed on Sunday, August 21, 2022.

Marti Brown is the City Manager for the City of Willows. After working as a Marketing Manager for AT&T (1997-2000), Marti took an Assistant Redevelopment Planner post in the City of Berkeley (2002-2005). In 2005 Marti became a Senior Redevelopment Planner for the Sacramento Housing & Redevelopment Agency (2005-2012). Between 2012 and 2016, Marti served as the Executive Director of the Franklin Boulevard Business Association. In 2016 she went to work for the City of Arvin as Community Development Director (2016-2017). In 2018 Marti was appointed Marysville City Manager (January 2018-July 2020). Marti served as a member of the Vallejo City Council (2009-2013).
