<u>Benicia</u> is located along the north bank of the Carquinez Strait in the

North San Francisco Bay Area. The City was founded in May 1847 on land sold by General Mariano Guadalupe Vallejo. The City is named for the General's wife Francisca Benicia Carillo de Vallejo. The 1848 California Gold Rush was off and running when the Sutter's Mill gold strike was leaked at a Benicia tavern. Benicia was the third California State Capitol site after San Jose and Vallejo. It served as the Capitol between February 11, 1853 and February 25, 1854. Benicia was the county seat of Solano County until 1958 when it was moved to Fairfield. Benicia incorporated in March 1850. It's 2019 population estimate is 28,240. Erik Upson is the City Manager and Mario Giuliani is the Deputy City Manager. The elected City Clerk is Lisa Wolfe.

Benicia City Manager Erik Upson previously served as the Chief of Police of the Benicia Police Department. Erik was appointed Interim City Manager when City Manager Lorie Tinfow stepped down in September 2020, after serving three-plus years in the position. Erik was appointed City Manager in January 2021. Erik joined the local police department in 2015 after worked 17-years for the Police Department in the City of Berkeley, where he was a Captain. Erik enlisted in the United States Army after graduating from high school and served 8-years. He earned a BA from the University of California, Berkeley and a Master's degree from California State University, Long Beach.

Originally named Silveyville, the Dixon area emerged as a community during the California Gold Rush. Silveyville was a good halfway point between the

Pacific Coast and the gold fields near Sacramento. When the Central Pacific Railroad came through the area in 1868 it missed Silveyville by a few miles. Local leaders decided to relocate the town closer to the tracks. Originally, the town name became "Dicksville" after **Thomas Dickson** who donated land for the railroad depot. When the first shipment of merchandise arrived from San Francisco in 1872, it was mistakenly addressed to "Dixon." Dixon incorporated in March 1878. Jim Lindley is the City Manager and Kristin Janisch is the Interim Elected City Clerk. Kate Zawadzki is the Dixon Finance Director.

<u>Fairfield</u> is the county seat of Solano County. It is generally considered at the midpoint between <u>San Francisco</u> and Sacramento. It is the home of

Travis Air Force Base and the headquarters of Jelly Belly, former President **Ronald Reagan**'s favorite candy. Fairfield incorporated in December 1903. The city's 2019 estimated population is 117,133. **Stefan Chatwin** is the City Manager and **David Gassaway** is the Assistant City Manager.

City Manager **Stefan T. Chatwin** was appointed in <u>Fairfield</u> in December 2019. He previously served as the City Manager in <u>Imperial</u>, California (2016-2019). Stefan served as an officer in the United States Air Force from 1993 to 1999. After a couple years in the private sector, Stefan was hired to work as the Director of Community Services in Ogden, Utah in 2001. In 2004 he was appointed City Manager in Santaquin, Utah, and in 2009 he became the City Administrator in Hayden, Idaho. Stefan than joined the <u>Imperial</u> city staff as City Manager in 2016. He earned a BA from Brigham Young University. In 2013, Stefan received a 10-year ICMA Service Award.

modern community. Founded in 1858, the settlement was renamed "Rio Vista" before a flood in 1862 the resulted in moving the town to higher ground. A <u>Rio Vista</u> post office was established in 1858. The city incorporated in January 1894. The 2019 estimated population of <u>Rio Vista</u> is 9,718. **Robert Hickey** is the City Manager and **Jose Jasso** is the Assistant City Manager/City Clerk.

City Manager **Robert Hickey** served as City Manager in the City of <u>Live Oak</u> from 1999 to 2007. He then spent about a year as City Manager in <u>Colusa</u> (2007-2008) before being appointed City Administrator in the City of <u>Gridley</u> in 2008. He left <u>Gridley</u> in 2015 and was appointed <u>Rio Vista</u> City Manager in August 2016. Robert served in the United States Air Force from 1974 to 1997. He earned a BS from Embry Riddle Aeronautical University.

<u>Suisun City</u> takes its name from the adjacent Suisun Bay. The community was established in the 1850s. Its location made it ideal for commerce and transportation during the California Gold Rush. The city incorporated in October 1868. Its 2019 estimated population is 29,663. **Greg Folsom** is the City Manager and **Donna Pock** is the Deputy City Clerk.

City Manager **Greg Folsom** served as the Deputy Director of Economic Development in Stockton from May 1993 to December 2011; more than 18-years. He worked in a similar position for the Riverside County Economic Development Agency between February 2014 and January 2015. Greg served as a Planning Commissioner in the City of Menifee in 2015, before he was appointed City Manager in the City of Clearlake in June 2015. Greg joined the city staff in Suisun City in April 2018. He earned a BS from San Jose State University and an MBA from the University of Southern California (**USC**).

<u>Vacaville</u> is approximately 35 miles from the State Capitol in <u>Sacramento</u>. In 1842 the Vaca and Peña families settle in the area of Lagoon Valley. The original township was established

in 1851 when nine square miles were deeded to William McDaniel and the original city plans were laid out. The town was named for Juan Manuel Cabeza Vaca. The town developed into an important produce center. Vacaville incorporated in August 1892. The 2019 estimated population of the city is 100,670. Aaron Busch is the City Manager and Michelle Thornbrugh is the City Clerk.

Aaron Busch served his first day as the <u>Vacaville</u> City Manager on Tuesday, May 16, 2017. He served as the Assistant City Manager starting in 2017 and he was promoted to Interim City Manager following the termination of City Rancho Cordova. Aaron earned a BA in geography from California State University, Fresno.

<u>Vallejo</u> is a waterfront city in the North Bay area of San Francisco Bay. The city is named for **Don Mariano Guadalupe Vallejo**. He was a leading proponent of California Statehood. He became one of the first members of the California State Senate. The neighboring city of Benicia is named for his wife. <u>Vallejo</u> served as the State Capitol in 1852 and in 1853. Though Vallejo is named for Don Mariano, the man regarded as the true founder of <u>Vallejo</u> is **John B. Frisbie**. He

married Don Mariano's daughter and given the power of attorney for the land grant. He hired **E. H. Rowe**, who designed the city layout, naming the east/west streets for states, and the north/south street for California counties. <u>Vallejo</u> incorporated in March 1868. Its 2019 estimated population is 121,692. Interim City Manager **Anne Cardwell** has announced that she is leaving the stepping down on October 7. She took over following City Manager **Greg Nyhoff**'s exit from the position.

Anne Cardwell was the serving Assistant City Manager when City Manager Greg Nyhoff negotiated his resignation. Greg was appointed Vallejo City Manager in 2018. He previously served as City Manager in Oxnard and Modesto. In 2018 Greg was appointed to the Board of the California City Management Foundation (CCMF). He received a 30-year ICMA Service Award.
