<u>Clayton</u> was founded by Joel Henry Clayton. Joel and his two younger brothers laid out the city in 1857 at the foot of

Mount Diablo in Contra Costa County. <u>Clayton</u> prospered during the coal mining boom in the area. The local post office was founded in 1861. The city was incorporated in March 1964 in an effort to preserve its independence from the neighboring city of <u>Concord</u>. The 2020 <u>Clayton</u> population is 11,070. **Adam W. Politzer** was appointed Interim City Manager effective April 15, and an executive search process was considered. **Stephanie Cabrera-Brown** is the City Clerk. **Prapti Aryal** served as the <u>Clayton</u> Finance Director between July 2023 and May 2024 when she took the Finance Director position for the City of <u>Sonoma</u>.



<u>Clayton</u> Interim City Manager **Adam W. Politzer** was the Menlo College Assistant Baseball Coach from January 1996 until June 1998. He was hired as the Softball Coach for the Kentfield Girls Softball team and work that job seasonally for more than 16 years starting in 2003. Adam was

appointed city manager for the City of <u>Sausalito</u> in September 2007, leaving that position in December 2020 when he retired. He became the <u>Fairfax</u> Town Manager in July 2021. After leaving <u>Fairfax</u> in March 2022, he completed an Interim City Manager assignment for the City of <u>Emeryville</u> (2022-2023) and as Interim Assistant City Manager for <u>East Palo</u> <u>Alto</u> (May 2023 to December 2023). He has done some management consulting, worked on a leadership & government study and served as a Business Coaching Specialist. In April 2024, he took the <u>Clayton</u> position from Chief of Police **Richard McEachin**, who worked as Acting City Manager following City Manager **Bret Prebula**'s leaving.

<u>Clearlake</u> is named for Clear Lake, the lake that defines Lake County. Clear Lake is the largest natural body of fresh water in California. It has become a premier bass fishing lake. <u>Clearlake</u> is one of the two cities in Lake County. The other is

Lakeport. The local post office opened in 1923 as "Konocti." It later changed its name to Clearlake Highlands until the city was incorporated as the City of <u>Clearlake</u>. The city was incorporated in November 1980. Its 2020 population is 16,685. **Alan Flora** is the <u>Clearlake</u> city manager, and **Melissa Swanson** is the City Clerk and Administrative Services Director. **Adeline Leyba** is the Director of Public Works, and **Tina Viramontes** is the Recreation & Events Coordinator.



<u>Clearlake</u> City Manager Alan Flora served as a Member of the Planning Commission for the Town of Flora, Indiana from 2004 to 2008. In 2008 he was hired as an Associate Planner by the County of Lake, California. In January 2011, Alan was hired as a Redevelopment Analyst by

the Lake County Redevelopment Agency. In 2012, Alan worked 5 months as an Analyst in the Administrative Office of Lake County, and starting in July 2012 he served as the Deputy County Administrative Officer. <u>Clovis</u> is a Fresno County city. Established in 1890 as the town became a freight stop for the San Joaquin Valley Railroad. The railroad bought the land from two farmers and the town was named Clovis for **Clovis Cole**, one of the

sellers. The lumber business developed in the area. The completion of a lumber flume in 1894 led to the development of lumberyards and a sawmill. <u>Clovis</u> was incorporated in February 1912. The 2020 population is 120,124. <u>Clovis</u> has a western town known for its slogan, "*Clovis*—A Way of Life". **John Holt** is the <u>Clovis</u> City Manager, and **Andy Haussler** is the Assistant City Manager. **Briana Parra** is the City Clerk.



John Holt took over for retiring <u>Clovis</u> City Manager Luke Serpa in 2021. John was a Financial Analyst with Boeing from January 1990 to November 1994 when he joined the city staff in <u>Visalia</u> in December. John worked for Visalia until December 1999 and

left as the Financial Service Manager. In January 2000, John was hired as a Management Analyst by the City of <u>Clovis</u>. After serving as the City Clerk (1994-2000), John became the Assistant City Manager in April 2009. He was elevated to the <u>Clovis</u> City Manager position in December 2021. Coachella is the community furthest east in the Coachella Valley. Beginning as a railroad town, Coachella has grown into an important agriculture and shipping business center. Coachella was originally established as "Woodspur" in 1876 when the Southern Pacific Railroad constructed a rail siding at the site. In 1901 the people of Woodspur voted on a new name for the community and selected, "Coachella." The city of Coachella was incorporated in December 1946. The 2020 population is 41,941. In the 1950s the city expanded in area which includes fruit groves, especially citrus and date palms. Dr. Gabriel Martin is the city manager and **Risseth Lora** is the Public Information Officer. The Economic Development Director is Celina Jimenez, and Gabriel Perez is the Development Services Director. Ruben Ramirez is the Controller, Castulo R. Estrada is the Utilities Director, and Maritza Martinez is the Public Works Director.
