California Public Managers in “C” Cities from Costa Mesa to Cypress



Costa Mesa was originally named Harper for a local rancher. It's first post office opened in 1909. The community's name officially became Costa Mesa in May 1920. The city was incorporated in June 1953. Its

2020 population is 111,918. It is home to the Orange County Fair Grounds and Event Center. Retired city manager **Douglas La Belle** is a member of the Fair Board of Directors. **Lori Ann Farrell Harrison** is the Costa Mesa city manager.



Costa Mesa City Manager **Lori Ann Farrell Harrison** was appointed in May 2019. She is the first woman in the city's history to serve as city manager. She began her public service career with the Division of the Budget of New York State in

September 1991. In 1996, she took the Director of Financial Compliance and Claims for the New York City Administration for Children's Services. After working as a Financial Advisor from 2000 to 2003, Lori moved to the west coast and took the Administrative Services Director position in the City of Lomita. She joined the Long Beach city staff as City Controller in February 2006, and she was promoted to Chief Financial Officer in September 2007. In 2010 Lori took the CFO position for the City of Huntington Beach, and she was appointed Assistant City Manager in July 2017. She served as the President for the Port of Long Beach starting in December 2013. Lori was selected to serve as the Costa Mesa city manager in July 2019. She earned a BA from Barnard College and an MPA from Columbia University. She is bilingual proficient in English and Spanish.

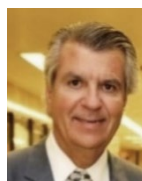

Cotati, says one legend, is named for a former Pomo Indian chief with the name Cotati. From 1858 the **Thomas Stokes Page** family owned the property where Cotati sits for more than 80 years. The land was used to graze cattle and sheep. In 1870 the San Francisco and North Pacific Railroad completed the first rail line from Petaluma and Santa Rosa. The town of Cotati formed around the wood and water stop called Page’s Station, which became Cotati. The city was incorporated in July 1963. The 2020 population is 7,584. **Damien O’Bid** is the city manager for the Sonoma County City of Cotati and **Angela Courter** is the Administrative Services Director.



Cotati City Manager **Damien E. O’Bid** served as the city’s City Engineer and Public Works Director starting in 2008. He added the duties of Assistant City Manager in 2014 in an Interim status. He became the Acting City Manager in 2015 and became City Manager in 2018. Prior to joining the Cotati city staff, Damien worked for more than a decade with the North Coast Regional Water Quality Control Board (NCRWQCB) and the Sonoma County Water Agency (SCWA).

City Manager **Dianne M. Thompson** served as the city manager for the City of Cotati from February 2007 until she resigned in December 2014. She worked as the City Manager for the Town of Ross from April 2015 to July 2015, and she replaced City Manager **Steve Adams** and Interim City Manager **Bob McFall** as the Arroyo Grande city manager from August 2015 until June 2016. Dianne began her public service career as a Facilities Planner for the City of Santa Rosa in March 1992, and she worked there until January 2004. She earned a BA from the University of California, Berkeley and a Master’s from Northwestern University. In 2014 she received a 20 Year ICMA Service Award.

Covina is in the San Gabriel Valley section of Los Angeles County. The city was established in 1882 by **Joseph Swift Phillips**. The city was named by **Frederick Eaton**, an engineer surveying the area.

Orange and grapefruit groves grew throughout the city. The city was the third-largest orange producer in the world as late as the 1950s. Covina incorporated in August 1901. The 2020 population is 51,268. **Chris Marcarello** is the Covina city manager and **Andrew Aleman** is the elected City Clerk. **Anita Agramonte** is the Finance Director starting in 2016.



Chris Marcarello began his public service career as a Project Manager and Budget Analyst for the City of Claremont in April 2001. In December 2005 he took an Administrative Analyst position for Newport Beach. He started as the Director of Public Works in the City of Rosemead in September 2007. In September 2014, Chris became the Deputy City Manager and Public Works Director for the City of San Fernando. He went to work for Glendale in April 2017 as their Assistant Director of Public Works. He was appointed Covina city manager in June 2018. Chris earned a BS from California State Polytechnic University, Pomona and an MBA from the University of Massachusetts. He also earned a Leadership Certificate from Claremont McKenna College.

Covina resident **Lloyd de Llamas** served as co-founder, past President and Executive Chairman of Hinderliter, de Llamas & Associates (**HdL Companies**). Prior to co-founding **HdL Companies**, he was California's first Hispanic City Manager. He served as City Manager of Monterey Park, Lawndale and Woodlake and as an Assistant in the cities of Torrance and San Diego. He is a past President of the San Gabriel Valley City Manager's Association. Lloyd received a 30 Year ICMA Service Award in 1993.

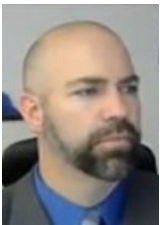

Crescent City is the only incorporated city in Del Norte County in Northern California where it is the county seat. In 1855, the building of a lighthouse at "the battery point" (a high tide island on the coast of Crescent

City) was authorized. The lighthouse still functions as a historical landmark. The local population includes inmates at Pelican Bay State Prison. The offshore geography makes the local coast unusually susceptible to tsunamis. The 1964, much of the city was destroyed by the Great Alaskan earthquake created tsunami waves, and in 2011 the earthquake off Sendai, Japan created waves that damage docks in Crescent City. **Eric Wier** is the City Manager and **Robin Altman** is the City Clerk. **Linda Leaver** is the Finance Director.



City Manager **Eric Wier** of Crescent City was appointed in 2018. He previously served as the Crescent City Public Works Director. Eric is a former member of the Crescent City Fire and Rescue Department, an organization that depends on volunteers.

Cudahy is a Los Angeles County city that has one of the highest population densities in the U.S. The city is named for its founder, **Michael Cudahy**, who was in the meat packing business. Many struggling farmers in the 1910s and 1920s moved west to find a new life, and many of them moved to Cudahy. The city was incorporated in November 1960. The 2020 population is 19,397. Former Cudahy Mayor **Fred Guido** served as President of the California Contract Cities Association (CCCA) in 1976. **Alfonso Noyola** is the Cudahy city manager and **Richard Iglesias** is the City Clerk. The Assistant City Clerk is **Estefania Zamora** and the Assistant to the City Manager is **John Peraza**.



Cudahy City Manager **Alfonso “Al” M. Noyola** served in the United States Air Force in Nevada. He left the service in 1999 and worked in the mortgage industry until 2003 when he joined the North Las Vegas city staff as an administrator in the

Police Department from March 2003 until January 2010. Alfonso worked as the Acting Director of Finance & Administrative Services for North Las Vegas from 2010 to 2012. He was appointed Director of Administrative Services for North Las Vegas in January 2012. Alfonso moved to California in January 2015 to serve as the City Manager for the City of Arvin. He left Arvin in March 2018 to become the city manager for Boulder City, Nevada, where he left in October 2020. He was hired to be the Cudahy city manager in July 2021. Alfonso earned an AA from the Community College of the Air Force, a BS from Wayland Baptist University and an MPA from Midwestern State University. In 2016, he received a 10 Year ICMA Service Award. Al is an ICMA Credentialed Manager.

Culver City is named for founder, **Harry Culver**. Harry tried to establish the city in 1913, but incorporation did not come until September 1917. In the 1920s, Culver City became a center for

film and later television program production companies. The city was founded as a whites-only community. Promotions for lot sales noted “restricted to Caucasian race.” In July 1941, Hughes Aircraft opened a plant. The world famous “Spruce Goose” was built there. **John M. Nachbar** is the city manager for the City of Culver City, and **Jeremy Bocchino** is the City Clerk. **Lisa Soghor** is the Chief Financial Officer, and **Ted Stevens** is the Parks, Recreation and Community Services Director.



City Manager **John M. Nachbar** of Culver City served as the Assistant to the City Manager in Wichita Falls, Texas in 1979-1982, and he worked as the Assistant City Manager in Overland Park, Kansas in 1982-1987. John came to

California as the City Manager for the City of Patterson where he served from 1987 to 1991. He took the City Administrator position in Albany, California from 1991 to 1995. In 1995, John took the Deputy City Manager job in Tucson, Arizona. He returned to Overland Park, Kansas in January 2000 as City Manager. After nearly 11 years, John was hired to be the city manager for Culver City starting in August 2010. John earned a BGS and MPA from The University of Kansas.

Lisa Soghor was appointed Culver City Chief Financial Officer in February 2022. She previously served as Assistant City Manager for the City of Malibu. She earned a BA from Princeton University and a Master of Landscape Architecture from the University of Pennsylvania. She received the 2014 Award of Excellence from the L.A. Business Council.



Jim L. Barisic, former Artesia City Manager who also worked in Cerritos and Paramount, and is a



Viet Nam veteran, founded **Brandywine** in 1994.

CUPERTINO

Cupertino, named by Spanish explorer Juan Bautista de Anza's cartographer, is a Santa Clara County city at the western end of the Santa Clara Valley. Once a fruit tree haven where plum, apricot and cherry orchards flourished. The first housing tract was constructed as a result of the development of an electric railway. Cupertino was incorporated in October 1955. The 2020 population is 60,381. **Pamela Wu** is the city manager and **Kirsten Squarcia** is the City Clerk. **Tina Kapoor** is the Deputy City Manager. **Chad Mosley** is the Cupertino Director of Public Works and City Engineer. The Recreation Manager of the Parks and Recreation Department is **Jenny Koverman**. **Daniel Degu** is the Economic Development Manager.



Cupertino City Manager **Pamela Wu** began her public service career as a Planner for the County of Santa Clara in 2001. She worked her way up in the organization during her more than 17 years county tenure. She was the Santa Clara County Employee of the Month in September 2014. Pam took a Senior Planner job for the City of Gilroy in February 2018. She moved to San Bruno in 2019 to be the Planning and Housing Manager. She was promoted to Community and Economic Development Director in October 2020; the first four months a “Acting.” In August 2022, Pam was recruited to serve as the City Manager for the City of Cupertino. She earned two BAs in architecture and regional planning from the University of California, Berkeley. She has an AICP license issued by the American Planning Association in May 2008. Pam has worked with the Children Ministry staff at the River Of Life Christian Church in Santa Clara since September 2013. She has taught Sunday School curriculum to 4th and 5th graders. 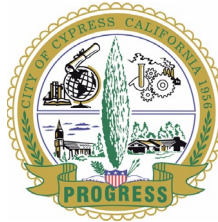

California Public Managers in "C" Cities from Costa Mesa to Cypress



Cypress is an Orange County city once nicknamed "Waterville" because of the artesian wells in the area. The city was incorporated in July 1956 with the name "Dairy City." Like neighboring cities of Dairy Valley (Cerritos) and Dairyland (La Palma), the effort was to protect local dairy farmers. The Dairy City name was changed to Cypress in 1957. The move to build suburbs following World War II pushed local property values beyond dairy farm use. The 2020 population is 50,151. As of September 2024, the median home sale price in Cypress was \$925,000. Retired Long Beach and Paramount City Manager **Pat West** lives in Cypress, as does the retired Cerritos Recreation Center Director **Jerry Simpson**. The late **Darrell Essex** served the longest of Cypress city managers at 34 years starting in 1962. Darrell passed away in 2019 at the age of 87. Well-known professional landscape photographer **Mark J. Ochendusko**, who retired as a city manager of Coronado in 2010, served as the Cypress city manager in 1996 - 1999. The current city manager is **Peter Grant** and **Alisha Farnell** is the City Clerk. **Alicia Velasco** is the Cypress Planning Director, and **June S. Liu** is the Director of Recreation & Community Services.

In 1978 he became the Deputy Director of the Mechanical Department in Los Angeles County, and following about a 3-year stint in private enterprise, Bruce took the Palm Desert city manager position in 1983 and retired in 1995. Bruce mentored an army of former assistants who went on to be city managers. Bruce earned a BS and MPA from Arizona State University.
