California City Managers Who Started In Planning

Well planned communities are most often the product of the combined efforts of well-informed and courageous policy makers, and professional land use planners. Environmental planners, ecological assessors, zoning administrators and code enforcers are responsible for the condition of a community's livability. Of course, it is not their sole responsibility. However, it is the planning craft whose primary concern is all aspects of a community's environmental future.

Land use planning is a public policy subject area that includes disciplines which seek to order and regulate the use of land efficiently and ethically. There are “counter” planners, long-range general plan specialists, and many specialties between and beyond.

Successful City Managers generally have a leadership skill-set that allows them to effectively direct staffing resources and control expenditures, while juggling the demands and group dynamics of a city council. Though some planners, often those deep in the bureaucracy of large organizations, may develop unrealistic “pie-in-the-sky” visions, the successful planners marry community welfare and desires with realistic economics.

Many California city managers have a community development, economic development or planning background or foundation. Though it is impossible to find and list everyone who fits this criteria due to time and space, we have done our best at ferreting out those with planning in their past to produce a good representative list. We have again used the ICMA Who's Who Directory as our primary research tool. We apologize in advance for any errors or omissions.

Buena Park City Manager **Rick Warsinski** was the city's Community Development Director prior to his appointment to the top spot. He has worked for the City of Buena Park for the past 27-years, and has worked in municipal government for 30-years. Rick is a Past President of the *Orange County Planning Directors Association*. He has a BA from Chapman University and a Masters Degree from California State University, Dominguez Hills.

Bell Gardens City Manager **John A. Ornelas** is considered an expert on redevelopment and economic development issues. He previously served as Commissioner of the Los Angeles Community Redevelopment Agency, the largest redevelopment agency in the country. Prior to his appointment in Bell Gardens, John served as the City Administrator in San Fernando and as Deputy City Manager in San Gabriel. He was also an Executive Management Consultant in Delano. John has a BA from the University of California, Santa Barbara, and an MA from **UCLA**'s School of Architecture and Urban Planning. His public service career spans some 25-years with the past four in Bell Gardens.

Kathleen A. "Kathy" Millison came to work for the City of Clovis in 1983 when she joined the staff as the Assistant City Manager. La Palma City Manager **Dominic D. Lazaretto** left municipal consulting in 2003 to become the La Palma Community Development Director. Dominic served as Assistant City Manager starting in October, 2005, and was appointed City Manager in July, 2007. Dominic was active in MMASC. La Palma was originally incorporated as "Dairyland," as one of three dairy cities in the region (the other two being Dairy Valley - now Cerritos and Dairy City - now Cypress). When the dairies moved in the 1960s Dairyland became La Palma. The City's population was 15,408 at the 2000 census. **La Palma was listed in 2007 by Money Magazine as the 16th best place to live among small cities (50,000 or less) in the United States.**

San Clemente is home to the annual summer San Clemente Ocean Festival with "The Greatest Show on Surf." This year the festival will be on the weekend of July 19-20. **George E. Scarborough** has been the San Clemente City Manager since August, 2003. George began his municipal government career in 1977 as the Planning Director in Greenfield. In 1978 he went to Scotts Valley for a similar position but returned to Greenfield in 1980 as the City Manager. In 1984 George was appointed City Manager in Los Altos Hills where he served until moving to San Juan Capistrano as the Assistant City Manager in December, 1988. George was appointed San Juan Capistrano's City Manager in 1993 and served there a little more than 10-years prior to his appointment in San Clemente. 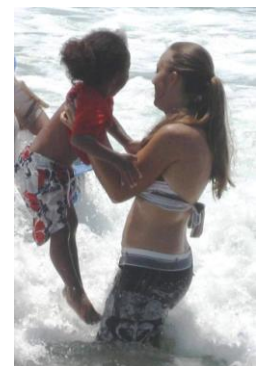

Bureau Veritas: Historically Superior Services

Bureau Veritas actually got its start in 1828, as the Information Office for Maritime Insurance, and had a simple mission: to give shipping underwriters up-to-date information on premiums in use at commercial centers and to provide precise information on the condition of ships and equipment.

In 1829, the company was renamed Bureau Veritas, adopted the emblem of Truth as its official logo and edited its first Register of some 10,000 ships. In 1833 the company's corporate office was transferred from Antwerp to Paris, where a branch office was established in 1830.

Bureau Veritas expanded into new areas such as "Control of Materials," for iron and steel inspection in the railway industry, as well as inspecting factory equipment. In 1922, the French government retained Bureau Veritas as the official control of airworthiness certificates for civil aircraft. In 1927 the company also created a service to check buses, coaches and trucks for worthiness.

Bureau Veritas brought its long technically proven history to the U.S. After the integration of US Laboratories in 2003, the company further strengthened its US capabilities in early 2004 with the acquisition of the long-time well-respected Berryman & Henigar firm, and Graham Marcus, whose services include code compliance, program and construction management, asset management and environmental services.

In early 2005 Bureau Veritas also acquired Linhart Petersen Powers Associates (LP2A), who specializes in services to US municipalities, particularly for construction code compliance. The acquisition of One CIS, the inspection division of the OneBeacon insurance group, gave Bureau Veritas access to inspection and assessment of pressure equipment to ASME standards in the country. Also, the 2005 acquisition of Clayton and NATLSCO reinforces Bureau Veritas' capabilities.

Yes, it is a large company, some 26,000 employees, with broad capabilities worldwide, but it has retained the personal service touch of a hometown business. **Roy Stephenson**, formerly of Berryman & Heniger, still maintains the lifelong business relationships and friends he has made during decades of providing professional services to local public agencies. Roy has brought on board retired Pomona City Manager **Doug Dunlap** to improve local contact, institutional memory and personal relationships.
