### Women Professionals in California's "Rancho" Cities

Rancho Mirage Incorporated in August, 1973 in the Coachella Valley of Riverside County. The estimated 2018 population is 18,336. Rancho Mirage has within its jurisdiction thirteen golf course. Although the first modern settlements date back to the 1920s and 1930s, Rancho Mirage got its claim to fame after World War II. The Annenberg Estate, or Sunnylands, owned by philanthropists Walter and Leonore Annenberg, was popular with celebrities, including Frank Sinatra, Bob Hope, Fred Astaire, Ginger Rogers, Patrick Macnee and Mary Martin. Several Presidents of the United States have vacationed at the Annenbera Nixon, Ronald including **Richard** Reagan, and Gerald Ford. President Ford later bought a house in Rancho Mirage and was living there at the time of his death in 2006. The current City Manager is Isaiah Hagerman, Kristie Ramos is the City Clerk.

**Letty Gallegos-Gallardo** is a Human Resources Specialist for <u>Rancho Mirage</u>.

Rancho Palos Verdes was incorporated in September, 1973 on the Palos Verdes Peninsula in Los Angeles County. The city's 2018 estimated population in 41,928. Point Vicente Interpretive Center is a premier whale-watching site that provides opportunities to view the annual migration of the Pacific gray whale from December through April. The Point Vicente Lighthouse, built in 1926, is adjacent to the center and is on the National Register of Historic Places. At another location along coast, Wayfarers Chapel, designed by Lloyd Wright (son of Frank Lloyd Wright) and built between 1949 and 1951, is also on the National Register of Historic Places. Currently, Ara Mihranian is the Rancho Palos Verdes Interim City Manager, Gabriella Yap was the Deputy City Manager, and Emily Colborn is the City Clerk.
