South El Monte is a city in the San Gabriel Valley of Los Angeles County. The city incorporated in July, 1958. Its 2019 population is 20,574. The city is historically known as "The End of the Santa Fe Trail." **Rachel Barbosa** is the City Manager and **Donna G. Schwartz** is the City Clerk.

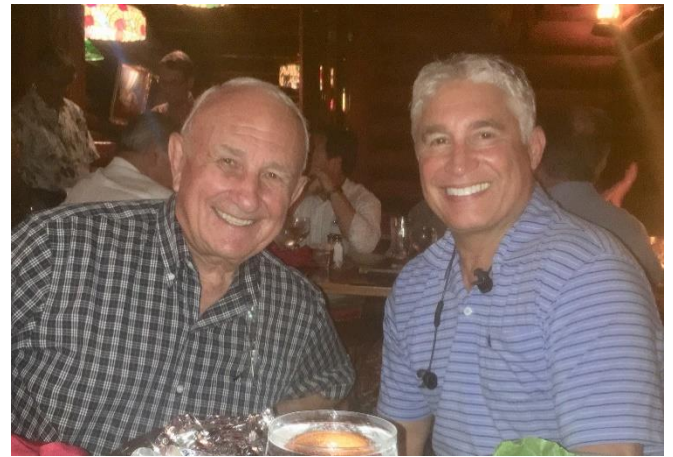

Still More Pieces Picked Up: La Verne continues to recruit for a new Fire Chief. Interim Fire Chief **Devon Leonard** resigned August 12. City Manager **Bob Russi** is authorized to appoint former Long Beach and Huntington Beach Fire Chief **David Segura** to assume the Interim Fire Chief role. There is sentiment in the department that the city go forward with service by the county Fire Department. Ventura County Chief Deputy District Attorney **Chuck Hughes** penned a letter to the Oxnard Mayor warning the city to conform to the Brown Act. WEAR YOUR FACE COVERING CORRECTLY

- Wash your hands before putting on your face covering
- Put it over your nose and mouth and secure it under your chin
- Try to fit it snugly against the sides of your face
- Make sure you can breathe easily
- Do not place a mask on a child younger than 2



USE THE FACE COVERING TO HELP PROTECT OTHERS

- Wear a face covering to help protect others in case you're infected but don't have symptoms
- Keep the covering on your face the entire time you're in public
- Don't put the covering around your neck or up on your forehead
- Don't touch the face covering, and, if you do, clean your hands

FOLLOW EVERYDAY HEALTH HABITS

- Stay at least 6 feet away from others
- Avoid contact with people who are sick
- Wash your hands often, with soap and water, for at least 20 seconds each time
- Use hand sanitizer if soap and water are not available



TAKE OFF YOUR CLOTH FACE COVERING CAREFULLY, WHEN YOU'RE HOME

- Untie the strings behind your head or stretch the ear loops
- Handle only by the ear loops or ties
- Fold outside corners together
- Place covering in the washing machine
- Wash your hands with soap and water



Cloth face coverings are not surgical masks or N-95 respirators, both of which should be saved for health care workers and other medical first responders.
