California Managers in Cities from Loomis to Los Banos



Loomis is a Placer County town that shares borders with the city of Rocklin. The town takes its name from a local pioneer, **James Loomis**. In the early 20th century, Loomis was the second largest fruit-shipping station in Placer County. Loomis was incorporated in December 1984, as a local control-home rule action, to prevent an annexation by the City of Rocklin. **Dirk Brazil** is the Interim Town Manager, and **Carol Parker** is the Town Clerk. **Ted Williams** is the Finance Director and **Cole Strombom** is the Town Treasurer. the Interim Town Attorney is **Frank Spendorio**.

Dirk Brazil worked as an Assistant Administrator for the County of Yolo from 2006 to 2014. Dirk became the Davis city manager in November 2014 and retired in January 2018. Since his retirement he has completed a number of "interim" assignments including as city manager in 2018 for South Lake Tahoe and Alameda (May 2022-February 2023). Dirk is a graduate of the University of California, Davis and Claremont Graduate School. He is a former Coro Fellow in Public Affairs, and a lifelong San Francisco Giants and Golden State Warriors fan.



Wes Heathcock served as Loomis Town Manager from June 2023 until Halloween 2025. Wes resigned to take a manager position with the City of Roseville. Wes grew up in the Lincoln, California area and worked for the city's community services (recreation) department for 15 years. He worked as the Colfax city manager for more than 5 years starting in December 2017, prior to joining the Loomis staff. He is a former Community Services Director in Colfax. Wes earned an MBA from Ashford University

California Managers in Cities from Loomis to Los Banos



Los Alamitos is Spanish for “the little cottonwoods.” The town of Los Alamitos was founded in 1896 by **Lewellyn Bixby** to support a sugar-beet factory he built with the Clark brothers. The community that grew

up around the factory, with streets of company houses for workers and surrounding farms, was called Los Alamitos. At the beginning of World War II, the Japanese farmers were rounded up by the military and relocated to internment camps in Manzanar and elsewhere. In February 1941, the Navy moved its reserve aviation training from Long Beach to the new “touch-and-go” airfield in Los Alamitos that became the nation's busiest reserve air base during the Korean War. This base has become the *Join Forces Training Base – Los Alamitos (JFTB)* and contains the *Los Alamitos Army Airfield (LAAAF)*. Los Alamitos is bordered by Cypress on the north and east, Garden Grove on the east, and Seal Beach on the south. The unincorporated Orange County area of Rossmore separates Los Alamitos from Long Beach. Los Alamitos was incorporated in March 1960. Its 2020 population is 11,780. The city manager is **Chet Simmons**, and the City Clerk is **Windmera Quintanar**.

Reviewing Los Alamitos city manager rosters discovers quite an impressive list of professional public managers. This is a cursory look that does not claim to be all inclusive, but a good representative look. **HdL Companies** Principal Consultant **Bret Plumlee** served as the Los Alamitos city manager and Human Resources Director starting in November 2013. Bob took the Placentia City Administrator position in September 2004 and served there until May 2008. He has worked as a Senior Advisor for ICMA since March 2013. Los Altos is a bedroom community at the western edge of the Silicon Valley in Santa Clara County. It was originally an agricultural town with apricot orchards and dotted with summer cottages. The community's origin reaches back to 1853 and was originally called "Banks and Braes". The early Southern Pacific Railroad service connecting the community ceased operation in January 1964. In 1976, Apple co-founders **Steve Jobs** and **Steve Wozniak** built their first 50 Apple I computers in Jobs's garage in Los Altos. In 2004, **Mark Zuckerberg** and a few of his friends introduced Facebook to the world. Los Altos was incorporated in December 1952. The city's 2020 population is 31,625. **Melissa Thurman** is the Los Altos City Clerk. **Gabriel Engeland** is the city manager, and **Jessie Kim** is the Finance Director.



Gabriel Engeland began his tenure as the Los Altos city manager in July 2021. He began his public service career in 2012 with the Town of Gilbert, Arizona. Gabriel came to Trinidad, Colorado in February 2015 to serve as city manager. In March 2017,

Gabriel started his time as city manager in the Los Angeles County, City of Sierra Madre. In July 2021 he joined the Los Altos staff as city manager. LOS ALTOS HILLS



Los Altos Hills is a city in Santa Clara County known for its high end, extremely expensive residential real estate. The city has a ban on commercial zones, which was upheld by the California Court of Appeal in 1973. Los Altos Hills' two retail operations are the bookstore on the campus of Foothill College and the gift shop on the grounds of the Immaculate Heart of the Poor Clare Colettines. The town does not have a post office or library. The Town Hall was built without public funds on land donated by the Town's 1st Mayor, **Arthur E. Fowle**. Construction funds were contributed by **Mr. and Mrs. Dawson**, and **William Simrell, Jr.** provided the architectural services. The town was incorporated in January 1956. The 2020 population is 8,489.

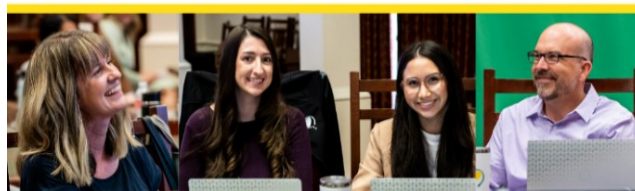

The area was initially settled in the 1840s. The town became a trading post. It got its name when the post office opened naming it after the nearby creek. The first post office opened in 1873. Los Banos has a history of Portuguese, Italian and Spanish immigrants, along with a community of Basques. The City of Los Banos was incorporated in May 1907. The 2020 population is set at 45,532. 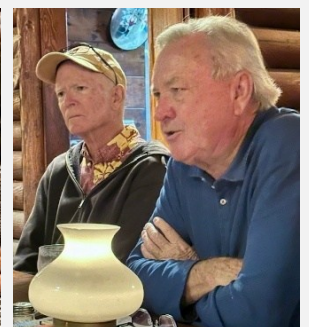

Picking Up the Pieces: Loomis Town Manager **Wes Heathcock** tendered his resignation without divulging the reason. Loomis Mayor **David Ring** says that the resignation was a surprise to him. Wes was appointed Town Manager in 2023 after he served as City Manager for Colfax starting in 2017. Former Davis City Manager (2014-

2017), **Dirk Brazil** will serve as Interim Town Manager. He served as Interim City Manager for South Lake Tahoe and Alameda, and Executive Director of the Downtown Davis Business Association. Millbrae Chief of Police **Eamonn Allen** is the subject of a formal complaint by Millbrae city manager **Randy V. Lum**.
