California City Executives in Cities of Pacifica to Palo Alto



Pacifica is a coastal city in San Mateo County about a dozen miles southerly of San Francisco. They say that Pacifica combines a close proximity to the urban areas of San Francisco and Silicon

Valley and Half Moon Bay with the laid-back surf culture of a Pacific Ocean beach community. Explorer Gaspar de Portolá sighted San Francisco Bay by climbing the hills of Sweeney Ridge in Pacifica in November 1769. Before that time, the bay's entrance had been missed as it was often cover by thick fog. The area is packed with fascinating history. From ancient native sites to Prohibition-era speakeasies, a 20th century Scottish castle, along with the discovery of San Francisco Bay. During World War II, the Sharp Park Detention Station was established to process Japanese Americans, Japanese national and other "foreign enemies". Stanford professor Yamato Ichihashi spent six weeks at the facility and wrote extensively about his experience. Pacifica was incorporated in November 1957. Its 2020 populations if 38,640. **Sean Charpentier** is the City Manager and **Yulia Carter** is the Assistant City Manager. **Sarah Coffey** is the City Clerk, and the Community Development Director is **Samantha Updegrave**. **Michelle Marchetta Kenyon** is the Pacifica City Attorney.

City Managers Who Served in the city of Lakeport, California

Kevin Ingram (July 2020–Present): Appointed following a tenure as the city's first Assistant City Manager and Community Development Director.

Margaret Silveira (April 2010 –July 2020): Served for a decade before retiring. In honor of her service, Lakeport named its community center building for her.

Kevin Burke (2009–2010/Interim): Served as the Acting/Interim City Manager concurrently while also serving as Lakeport's Chief of Police.

Jerry Gillham (2007–2009): Appointed as Lakeport's second permanent city manager after transitioning from public management positions in Oregon.

Randy Johnsen (2001–2006): Served as Lakeport's first official city manager until he retired in 2006. Randy previously served as city manager in the cities of Orland, Jone, and Cotati. Since retirement, Randy has been interim city manager in the cities of Yreka, Dunsmuir and Gridley. He started as an Intern in Lakewood.

Former city of Pacifica city managers include:

Kevin Woodhouse (October 2017 – March 2026)
Kevin served as one of the city's longest-tenured managers before his retirement in the spring of 2026.

Lorie Tinfow (October 2013 – March 2017) Lorie was appointed as the first female City Manager in Pacifica's history before moving on to become the City Manager for the city of Benicia;

Stephen Rhodes (2007 – July 2013)
Served as city manager for six-years and came out of retirement in Oregon to guide Pacifica through the late-2000s.



Joseph Tanner, served as Pacifica city manager from 2003 to 2006 when he was initially hired as an Interim City Manager. Joe left to become the Vallejo city manager in 2006. Joe previously was city manager for Pleasant Hill, Emeryville and Galt.

Karl Baldwin (c. 1958)
Karl is recognized historically as the first Pacifica permanent City Manager following the city's formal incorporation in late 1957.

Jane Hicks (c. 1957)
Served as the initial **Acting City Manager** to help set up early municipal protocols as cityhood was established.

Palm Desert has been one of the most rapidly growing cities in the Coachella Valley area of Riverside County. The area was called Old MacDonald Ranch in the early days, and the name change to

Palm Village in the 1920s when groves of date palms were planted. The first large scale residential development began in 1943 in connection with the United States Army's Desert Training Center, built under the leadership of **General George S. Patton** during WW II. Following the war on the south side of Highway 111 the development of "El Paseo", and upscale shopping district copied for Rodeo Drive. In 1948, the Palm Desert Corporation began developing property, and in 1951 the area was named "Palm Desert." The first post office opened in July 1947. Palm Desert was incorporated in November 1973. The 2020 population is 51,163. **Chris Escobedo** is the City Manager in Palm Desert, and **Richard Cannone** is the Assistant City Manager. **Anthony Mejia** is the City Clerk. The Director of Economic Development is **Martin Avarez**, **Lauri Aylaian** is the Director of Community Development and the Director of Finance in **Paul Gibson**.

Chris Escobedo, who started in Palm Desert as Assistant City Manager, is the City Manager in the city since September 2022 when he succeeded City Manager **Lawrence “Todd” T. Hileman**, who is the city manager for the city of South Pasadena. Chris served as the Assistant to the City Manager in Indio from February 2006 until March 2013, when he was hired as the Community Resources Director in La Quinta. He served there until he was hired in Palm Desert. Chris earned a BA from the University of California, Berkeley and an MPA from California State University, San Bernardino. In 2008-2009, Chris served on the Board of the Municipal Management Association of Southern California (MMASC).



Former Palm Desert Interim Assistant City Manager **Richard D. Cannone** has been the Assistant City Manager in Palm Desert since March 2025. Before 2022, Richard worked for the city of Denton, Texas. He came to Palm Desert as Deputy Director of Development Services in May 2022. He became Director of Development Services in November 2022. Richard earned a BA in community and regional planning from Iowa State University.

Highly thought of longtime Palm Desert City Manager **John Wohlmuth** was working as executive director for the Coachella Valley Association of Governments (CVAG) in February 2009 when he was hired to replace longtime Palm Desert City Manager **Carlos Ortega**, who was a Vietnam Veteran, and began his city career in 1972 with the city of Coachella. Carlos worked for the city of Palm Desert for 31 years and was city manager from 2000 to 2008 when he retired. He replaced city manager **Bruce A. Altman**, who also retired as Palm Desert city manager. Bruce retired in 1995 due to contracting multiple sclerosis. He received a 30 Year ICMA Service Award. Bruce passed away on April 12, 2017, at the age of 79 of congestive heart failure. **Lauri Aylaian** served as the Palm Desert city manager from October 2016 until her retirement in November 2020. After retiring she was interim Parks and Recreation Director for Palm Springs for a time.

California City Executives in Cities of Pacifica to Palo Alto



Palm Springs is a nationally known Riverside County desert resort city on the Colorado Desert of the Coachella Valley. Palm Springs, where many celebrities maintain homes, has become a retirement

location and a winter "snowbird" gathering place for those who live in winter snow, many from Canada. When the United States joined World War II, Palm Springs and the Coachella Valley became important to the war effort. The airfields were important to logistics, and after Pearl Harbor Day, the El Mirador Hotel was obtained by the U.S. government and converted into Torrey General Hospital. Following the end of the war, the area began a transformation to a resort destination and an area with modern architecture for commercial development and housing for celebrities and the rich. Palm Springs incorporated in April 1938. The 2020 populations totaled 44,575. **Scott Stiles** is the Palm Springs city manager, and **Teresa Gallavan** and **Flinn Fagg** are the Assistant City Managers. **Brenda Pree** is the City Clerk. Andrew Mills is the Chief of Police and Jeffrey Ballinger is the City Attorney.

What began as a filming location in the silent film beginnings, developed into an exclusive area for film star private living. One of the first stars to recognize the allure of Palm Springs was **Rudolph Valentino**, and by the 1920s others joined him, like **Clara Bow**, **Rex Bell** and many other actors, directors and studio executives. **Charlie Farrell** and **Ralph Bellamy** opened the Palm Springs Racquet Club in 1934, and it became the center for Hollywood desert gatherings. **Norma Jean Mortenson** was photographed at the club and soon became the legendary actress, **Marilyn Monroe**. **Clark Gable**, **Carole Lombard**, **Humphrey Bogart** and **Marlene Dietrich** spent weekends at the club. The Rat Pack landed in Palm Springs. They include **Frank Sinatra**, **Dean Martin**, **Sammy Davis Jr.**, and **Peter Lawford**. **Sonny Bono**, of Sonny and Cher, served as the Mayor in Palm Springs in the 1980s. Sonny started the Palm Springs International Film Festival. **Bob Hope**, **Dinah Shore** and **Lionardo DiCaprio** and members of the Kardashians, **Liberace**, **Sophia Loren**, **Elizabeth Taylor**, **Brad Pitt**, and many more are/were among Palm Springs visitors and owners.

For more than 40 years, Sunny lands, located in nearby Rancho Mirage, was a place for celebrities, Presidents, business leaders and even British royalty, to visited. Queen Elizabeth II is among to historic guests. **Walter and Leonore Annenberg** built Sunny lands, named for a former home they had in Pennsylvania. Walter made much of his worth by publishing TV Guide and the magazine, Seventeen. Sunnylands. Both Walter and Leonore served in Ambassador in the United States government. Sunnylands is a 25,000 square foot home on 200 acres. The estate became known as the "Camp David of the West." President **Richard Nixon** fled to Sunnylands immediately following his resignation. Palm Springs City Manager **Scott Stiles** started his career in Ohio. He joined the Cincinnati city staff as a Human Resources Analyst in May 1988. Scott worked his way up in the Cincinnati organization. In July 1991, he became an Assistant Legal Administrator; July 2000, the Real Estate Manager; Assistant to the City Manager in July 2002; and Assistant City Manager in February 2005. Scott was tapped to serve as Interim City Manager in December 2013, and he went back to the Assistant City Manager post in September 2014. He came to California in August 2015 to be the Garden Grove city manager, and he was hired as city manager in Palm Springs in March 2023. Scott earned a BS in journalism and geography from South Dakota State University, and an MCP in community planning from the University of Cincinnati.

Former Palm Springs city managers include a former Pasadena and Oakland city staff member, **William E. Alworth**, who was appointed Palm Springs city manager in December 1945. He served as city manager until 1950 when **Russell W. Rink**, an Assistant to the City Manager in San Diego, was hired to be city manager. In September 1953, political friction led to Russell's resignation and the appointment of Assistant City Manager **Robert W. Peterson** to take his place. After the tenures of **Daniel Wagner** (1963-1968) and **Frank U. Alworth** (1968-1973), **Donald A. "Don" Blubaugh** became the Palm Springs city manager in August 1973 and served until November 1979, when he left to become the Hayward city manager. He later served in Walnut Creek (1988-2002) and other communities. Don was President of the City Managers' Department of the League of California Cities in 1990-1991. **Norman R. King** was Palm Springs city manager from 1979 until June 1990 after being the Claremont city manager (1975-1979), and before serving as Moreno Valley city manager (1991-1996). He was President of the International City/County Management Association (ICMA) in 1995. After **Bob Parkins** Palm Springs city manager tenure (1990-2000), **David Ready** began his long service as city manager from February 2000 until his retirement in March 2021. David is now a member of the Palm Springs city council. **Justin Clifton** served for a short time (April 2021-July 2022) before the appointment of **Scott Stiles**. Assistant City Manager **Teresa Gallavan** filled the gaps as Interim City Manager.

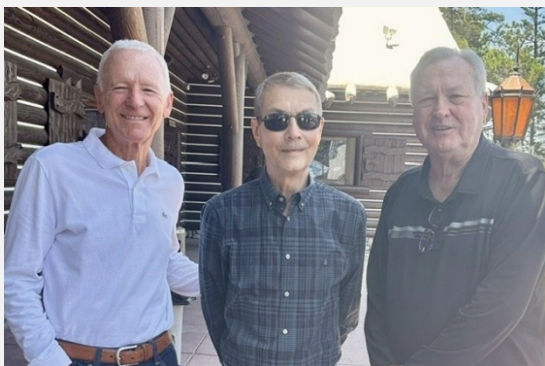

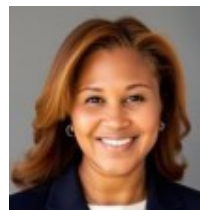

Former Palo Alto city manager include **Jerome “Jerry” Keithley** (1950-1966). Jerry was appointed following the 1950 charter amendment approving the council-manager form of government. Jerry went on to serve in Oakland and Glendale. He was the Stockton city manager prior to joining Palo Alto. Jerry served as President of the City Managers' Department of the League of California Cities in 1968-1969, and as an ICMA Regional Vice President in 1973-1975. 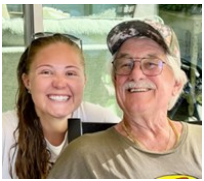

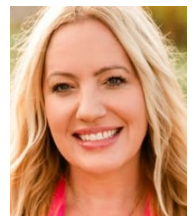
California's state government has sued the United States EPA over efforts to subject California's Clean Air Act waivers to Congressional review. These

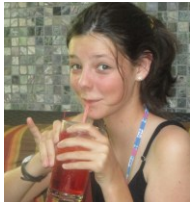
